FLUXYS BELGIUM S.A. reminds you that it is your sole responsibility to inform FLUXYS BELGIUM S.A. of any change which (might) impact(s) your Qualification.

Any non-compliance of which FLUXYS BELGIUM S.A. has been informed in application of the above, or which FLUXYS BELGIUM S.A. detects on its own initiative might lead to suspension of your Qualification.

In case of serious offence, false information, lack of notification of major changes, FLUXYS BELGIUM S.A. is entitled to withdraw immediately and without prior notice this acceptance granted to you. The acceptance is thus not permanently granted.

In order to administer the Approved Supplier List, FLUXYS BELGIUM S.A. will take into account all important events that might occur such as :

- a) the satisfaction, or the difficulties encountered during the execution of an order;
- b) the quality of the answers to the requests for price bidding;
- c) the annual or occasional information provided;
- d) any other information that might incidentally be obtained.

Should the information received sub a), b), c) or d) above, or any change regarding the acceptance criteria lead to a withdrawal of the acceptance, FLUXYS BELGIUM S.A. will notify to you its withdrawal intention concerning this acceptance, which will, however, only effectively be withdrawn if the Supplier is unable to improve his situation or to comply with the new conditions within a reasonable delay which normally should not exceed three (3) months.



Besides, FLUXYS BELGIUM S.A. has the right to terminate the acceptance of the Approved Supplier should one of the following events occur:

- a) in a situation of bankruptcy, liquidation, ceasing business, composition or preventive composition or any similar situation which exists in his national laws and rules;
- b) he owns up to having made bankruptcy or is subject to a liquidation procedure, composition or any similar situation existing in his national laws and rules;
- c) he has been convicted through a res judicata sentence for an offence liable to affect his professional morality;
- d) he has committed a serious offence whatsoever on a professional level and which can be established by FLUXYS BELGIUM S.A. by any means;
- e) he did not meet his obligations as for the payments of social security contributions according to the legal provisions applicable in Belgium or in the country in which he is settled;
- f) he did not meet his obligations as for the payment of taxes according to the legal provisions applicable in Belgium or in the country in which he is settled;
- g) he made himself guilty of false declarations by providing claimable information.

In no way, your acceptance can be considered as granting you any rights whatsoever towards FLUXYS BELGIUM S.A., which will by no means have its responsibility committed, especially in case of withdrawal of this acceptance, for any reasons for which it keeps the exclusive right of appreciation.
